**TENTATIVE 2019 BUDGET FOR WYOMING COUNTY ADOPTED**

**BE IT RESOLVED**, That the tentative budget for the year 2019, as filed with the Clerk of this Board, is hereby adopted as the county budget for the year 2019, which requires the raising by tax levy in the amount of twenty-one million five hundred eighty-seven thousand one hundred seventy-seven dollars (\$21,587,177.00); and be it

**FURTHER RESOLVED**, That the said sum of twenty-one million five hundred eighty-seven thousand one hundred seventy-seven dollars (\$21,587,177.00) be hereby levied against the taxable property within the County, as equalized by this Board, and the Chairman and/or Clerk of the Board is hereby directed to apportion and spread said sum against the properties within the County, which are subject to taxation; and be it

**FURTHER RESOLVED**, That the several amounts specified in such budget in the column entitled "ADOPTED", and the totals for the several objects set forth below, be appropriated for such objects effective January 1, 2019.
