**Chairman of the Wyoming County Board of Supervisors, Jerry L. Davis, reports:** As of earlier today, Wednesday, April 22, the Wyoming County Health Department reports fifty-five (55) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of two (2) from Tuesday, April 21.
