Chairman of the Wyoming County Board of Supervisors, Jerry L. Davis reports as of earlier today, Wednesday, June 03, the Wyoming County Health Department continues to report eighty-two (82) lab-confirmed positive cases of COVID-19 among Wyoming County residents. There is no increase since the last reported increase on Monday, June 01.
