Chairman of the Wyoming County Board of Supervisors, Jerry L. Davis as of earlier today, Tuesday, June 16, the Wyoming County Health Department reports eighty-five (85) lab-confirmed positive cases of COVID-19 among Wyoming County residents. That is an increase of one (1) case from the last reported increase on Monday, June 8.
