Chairman of the Wyoming County Board of Supervisors, Jerry L. Davis as of earlier today, Wednesday, June 17, the Wyoming County Health Department reports eighty-five (85) lab-confirmed positive cases of COVID-19 among Wyoming County residents. That is unchanged from the last reported increase on Tuesday, June 16.
