Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, reported as of earlier today, Wednesday, July 8, the Wyoming County Health Department reports ninety-two (92) lab-confirmed positive cases of COVID-19 among Wyoming County residents. That is an increase of one (1) from the last reported increase on Tuesday, July 07.
