**PRESS RELEASE**

Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, reported as of earlier today, Tuesday, July 14, the Wyoming County Health Department reports ninety-six (96) lab-confirmed positive cases of COVID-19 among Wyoming County residents. That is an increase of one (1) case since the last reported increase on Thursday, July 13.
