Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, reported as of earlier today, Wednesday, July 15, the Wyoming County Health Department reports ninety-six (96) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is unchanged since the last reported increase on Monday, July 13.
