Chairman of the Wyoming County Board of Supervisors, Jerry L. Davis, reported as of earlier today, Wednesday, July 22, the Wyoming County Health Department reports one hundred three (103) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of one (1) case from the last reported increase on Tuesday, July 21.
