**PRESS RELEASE**  
**July 23, 2020 @ 2:00 p.m.**

Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, reported as of earlier today, Thursday, July 23, the Wyoming County Health Department reports one hundred three (103) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is unchanged from the last reported increase on Wednesday, July 22.
