Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, reports, as of earlier today, Monday, August 10th, the Wyoming County Health Department reports one hundred fourteen (114) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of two (2) since the last reported increase on Thursday, August 6th.
