Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, reports, as of earlier today, Monday, August 24th, the Wyoming County Health Department reports one hundred nineteen (119) lab-confirmed positive cases of COVID-19 among Wyoming County residents. **This is an increase of three (3) cases from the last reported increase on Thursday, August 20th.**
