## PRESS RELEASE August 27, 2020 @ 2:00 p.m.

Chairman of the Wyoming County Board of Supervisors, Jerry L. Davis, reports, as of earlier today, Thursday, August 27<sup>th</sup>, the Wyoming County Health Department reports one hundred nineteen (119) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is unchanged from the last reported increase on Monday, August 24<sup>th</sup>.
