Wyoming County Board of Supervisors Vice Chair, **Rebecca J. Ryan**, reports, as of earlier today, Friday, September 11th, the Wyoming County Health Department reports one hundred twenty-one (121) lab-confirmed positive cases of COVID-19 among Wyoming County residents.
