Ryan**, reports, as of earlier today, Tuesday, September 22nd, the Wyoming County Health Department reports one hundred twenty-six (126) lab-confirmed positive cases of COVID-19 among Wyoming County residents. There are no increases from the last reported increase on Friday, September 18, 2020.
