Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan**, reports, as of earlier today, Thursday, October 01st, the Wyoming County Health Department reports one hundred thirty-three (133) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is unchanged from the last reported increase on Monday, September 29, 2020.
