Ryan**, reports, as of earlier today, Monday, October 5th, the Wyoming County Health Department reports one hundred forty (140) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of six (6) from the last reported increase on Friday, October 02, 2020.
