Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan**, reports, as of earlier today, Tuesday, October 13th, the Wyoming County Health Department reports one hundred fifty-eight (158) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of eight (8) from the last reported increase on Friday, October 09, 2020.
