Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced today, Wednesday, December 16, 2020, the Wyoming County Health Department reports seven hundred eighty (780) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of twenty-six (26) cases from the last reported increase on Tuesday, December 15, 2020.

Information Update (December 16, 2020):

How can I get a COVID-19 test in Wyoming County?

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan, reports today, Sinclair Pharmacy is no longer offering free drive up community COVID-19 testing through the HealthMart program. Sinclair Pharmacy, located at 75 North Main Street in Warsaw currently has limited rapid testing available for a cost of \$75.00, some insurances are accepted. For more information please contact Sinclair Pharmacy at 585-786-2330. The free testing program was part of the limited public-private partnership, announced in March by eTrueNorth, which worked with HHS, state and local officials, and pharmacy and lab partners to open testing sites in areas of need.

"We would like to extend our sincere thanks to Sinclair Pharmacy, Jim Rutowski and his staff for providing many months of testing services during the pandemic with a grant through eTrueNorth and Health Mart pharmacies," said Becky Ryan, Chair of the Wyoming County Board of Supervisors. *"They have gone above and beyond to serve our residents and we all appreciate the tremendous effort and service to the community."*

For testing in Wyoming County, please contact your healthcare provider. Most healthcare providers in Wyoming County can test in their offices. However, availability is subject to appointment capacity and patient circumstances. Be aware that some insurance carriers may not pay for COVID-19 tests that are not considered "medically necessary". Check with your insurance carrier and/or your healthcare provider for more information.

Individuals can also be COVID-19 tested at Wyoming County Community Health System Outpatient Laboratory, located on the first floor at 400 North Main Street in Warsaw. Testing will be available during normal business hours, Monday through Friday from 5:30am to 6:00pm and Saturdays from 8:00am to 2:00pm (closed on Sundays). You must have a prescription from your healthcare provider either in hand or faxed before your arrival; insurance or payment is required.

The Health Department will also be scheduling FREE COVID-19 drive-through rapid test clinics for people who live or work in Wyoming County. Clinics will be held at locations throughout Wyoming County and are by appointment only. Individuals may call the Wyoming County Response Line at 786-8911, Monday through Friday, 8:30am - 3:30pm to register and to find the date and location of the next clinic.
