From the Wyoming County Department of Health:

If you are in the Phase 1A or 1B Priority Population according to the NYS Department of Health [“Phased Distribution of the Vaccine”](#) guidelines, you are currently eligible to receive a COVID-19 vaccination.

Additional COVID-19 vaccination clinics will be scheduled when more vaccine is received. The Health Department cannot take reservations over the phone. Please check back frequently at www.wyomingco.net for updated information.

At current vaccine supply levels from NYS, it may take months to vaccinate everyone eligible in Phases 1A and 1B.

On Friday, January 22 New York Gov. Andrew Cuomo said he will allow high-risk youth sports to begin play on Monday, February 1 – with the provision that local health departments and school superintendents also give their approval. As a region, the local health departments of the Finger Lakes (including Monroe, Ontario, Wayne, Livingston, Genesee, Orleans, Wyoming, Seneca and Yates counties) are in support of re-opening high-risk sports but want to make sure it’s done safely and uniformly. As a region, we will be discussing and drafting additional guidance with our school partners to ensure a consistent, regional approach. Guidance should be provided this week.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Monday, January 25, 2021, the Wyoming County Health Department reports one thousand seven hundred sixty-one (1,761) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of twenty-eight (28) cases from the last reported increase on Friday, January 22, 2021.
