**From the Wyoming County Department of Health:**

The Health Department received one hundred 1<sup>st</sup> doses of Moderna COVID-19 vaccine from NYS this week. Second dose clinics are in process. At this time, New York State [Executive Order 202.91](#) requires health departments to focus on essential workers in Priority Population 1B.

If you are in the Phase 1A or 1B Priority Population according to the NYS Department of Health "[Phased Distribution of the Vaccine](#)" guidelines, you are currently eligible to receive a COVID-19 vaccination.

Beginning February 15, 2021 adults of any age with certain pre-existing conditions will be eligible to be vaccinated. The Health Department will schedule clinics for next week based on vaccine supply and updated guidance from NYS.

Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan** announced as of Wednesday, February 10, 2021, the Wyoming County Health Department reports one thousand nine hundred seventy (1,970) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of fourteen (14) cases from the last reported increase on Tuesday, February 9, 2021.
