**From the Wyoming County Department of Health:**

**NEW:** There will be a COVID-19 Moderna vaccination clinic held on Wednesday, March 3 from 9am to 12:30pm. According to directions from New York State, this clinic is *only for essential workers in Priority Population 1B* (this includes fire, law enforcement, public safety/communications, corrections, P-12 education employees, in-person college faculty, employees of registered group childcare programs, public transit, public-facing grocery workers & hotel workers, restaurant employees and others). Individuals being vaccinated must bring proof of eligibility to the vaccination site. This could be an employee ID card, a letter from an employer or affiliated organization, or a pay stub.

**Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Monday, March 1, 2021, the Wyoming County Health Department reports two thousand one hundred sixteen (2,116) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of twenty (20) cases from the last reported increase on Friday, February 26, 2021.
