New: Sign up with the Wyoming County Chamber of Commerce to receive local [COVID-19 Vaccine Alerts](#). The Chamber has created a quick sign up form to receive email alerts on vaccine availability, eligibility and registration notices. If you choose to sign up, you will not receive non-vaccine related emails.

Visit the NYS [“Phased Distribution of the Vaccine”](#) site to determine if you are eligible to receive the COVID-19 vaccine.

The Wyoming County Health Department anticipates a weekly allocation of vaccine, subject to supply and delivery by New York State. Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Friday, March 19, 2021, the Wyoming County Health Department reports two thousand two hundred forty-eight (2,248) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of six (6) cases from the last reported increase on Thursday, March 18, 2021.
