Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, reported as of earlier today, Tuesday, July 7, the Wyoming County Health Department reports ninety-one (91) lab-confirmed positive cases of COVID-19 among Wyoming County residents. That is an increase of one (1) from the last reported increase on Monday, July 06.
