Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, reported as of earlier today, Tuesday, July 21, the Wyoming County Health Department reports one hundred two (102) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of three (3) cases from the last reported increase on Monday, July 20.
