Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, reported as of earlier today, Friday, July 24, the Wyoming County Health Department reports one hundred five (105) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of two (2) from the last reported increase on Wednesday, July 22.
