Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, reports, as of earlier today, Friday, July 31, the Wyoming County Health Department reports one hundred seven (107) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of one (1) from the last reported increase on Tuesday, July 28.
