**PRESS RELEASE  
August 19, 2020 @ 2:00 p.m.**

Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, reports, as of earlier today, Wednesday, August 19<sup>th</sup>, the Wyoming County Health Department reports one hundred fifteen (115) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is unchanged from the last reported increase on Tuesday, August 18<sup>th</sup>.
