**Wyoming County Board of Supervisors Vice Chair, Rebecca Ryan**, reports, as of earlier today, Wednesday, September 9<sup>th</sup>, the Wyoming County Health Department reports one hundred twenty (120) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is unchanged from the last reported increase on Monday, August 31<sup>st</sup>.
