Wyoming County Board of Supervisors Vice Chair, **Rebecca J. Ryan**, reports, as of earlier today, Thursday, September 17th, the Wyoming County Health Department reports one hundred twenty-three (123) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is unchanged from the last reported increase on Monday, September 14, 2020.
