Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan**, reports, as of earlier today, Friday, September 18th, the Wyoming County Health Department reports one hundred twenty-six (126) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of three (3) cases from the last reported increase on Monday, September 14, 2020.
