Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan**, reports, as of earlier today, Friday, September 25th, the Wyoming County Health Department reports one hundred thirty (130) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is unchanged from the last reported increase on Thursday, September 24, 2020.
