Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan**, reports, as of earlier today, Thursday, October 8th, the Wyoming County Health Department reports one hundred forty-eight (148) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of one (1) from the last reported increase on Wednesday, October 07, 2020.
