Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan**, reports, as of earlier today, Wednesday, October 14th, the Wyoming County Health Department reports one hundred sixty (160) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of two (2) from the last reported increase on Tuesday, October 13, 2020.
