Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan**, reports, as of earlier today, Monday, October 19th, the Wyoming County Health Department reports one hundred seventy-three (173) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of seven (7) from the last reported increase on Friday, October 16, 2020.
