Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan**, reports, as of earlier today, Wednesday, October 21st, the Wyoming County Health Department reports one hundred eighty-one (181) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of six (6) from the last reported increase on Tuesday, October 20, 2020.
