Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan**, reports, as of earlier today, Monday, October 26th, the Wyoming County Health Department reports one hundred ninety-two (192) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of six (6) cases from the last reported increase on Friday, October 23, 2020.
