**Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan**, reports, as of earlier today, Monday, November 02, 2020, the Wyoming County Health Department reports two hundred seven (207) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of six (6) cases from the last reported increase on Friday, October 30, 2020.

As many Wyoming County families plan for the upcoming holiday season, The Wyoming County Health Department is sharing guidance from the NYS Department of Health on how to take part in celebrations in ways that reduce the risk of spreading COVID-19.
