**PRESS RELEASE

From the Wyoming County Department of Health:

Following discussion among Finger Lakes and Western Region County Health Officials, it has been determined that higher-risk and moderate risk sports may proceed in Wyoming County in accordance with New York State Guidelines. New York State Interim Guidelines for Sports and Recreation were announced by Governor Cuomo late Friday, January 22 and will become effective February 1, 2021. The Health Department will work closely with Wyoming County school districts as they develop plans for the safety and health of their student athletes, participants, district families, faculty and staff.

If you are in the Phase 1A or 1B Priority Population according to the NYS Department of Health [“Phased Distribution of the Vaccine”](#) guidelines, you are currently eligible to receive a COVID-19 vaccination. [HERE](#) is a current list of locations in Wyoming County that are registered with New York State as vaccine clinics; appointments are subject to vaccine availability.

If you received your 1st dose of Moderna vaccine on January 12, 13 or 14 at the Wyoming County Highway Department, watch for an email from the Health Department scheduling the time and date of your 2nd dose of vaccine.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Friday, January 29, 2021, the Wyoming County Health Department reports one thousand eight hundred fifty-eight (1,858) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of fourteen (14) cases from the last reported increase on Thursday, January 28, 2021.
