From the Wyoming County Department of Health:

NEW: New York State will be providing doses of Pfizer COVID-19 vaccine to the Health Department specifically for Wyoming County residents aged 65 and older. Clinic registration information will be announced shortly at www.wyomingco.net by choosing “COVID-19 Vaccination Clinic Registration” under *County Quick Links* or follow us on Facebook @Wyoming County Health Department.

NEW: Local leaders in Genesee, Orleans and Wyoming Counties are in discussions with New York State regarding a regional COVID-19 vaccination site at Genesee Community College in Batavia. The clinic would be for any resident of Genesee, Orleans or Wyoming Counties who is eligible to receive the COVID-19 vaccination according to the New York State [“Phased Distribution of the Vaccine”](#) guidelines. More information will be released as details becomes available.

Registration has closed for the March 3rd COVID-19 vaccination clinic for essential workers in Priority Population 1B. Additional clinics for eligible residents will be scheduled as more vaccine is received from New York State.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Tuesday, March 2, 2021, the Wyoming County Health Department reports two thousand one hundred twenty-three (2,123) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of seven (7) cases from the last reported increase on Monday, March 1, 2021.
