**From the Wyoming County Department of Health:**

**NEW:** The COVID-19 Moderna vaccination clinic for Wyoming County residents on Thursday, March 18 has filled, there are no remaining appointments.

The Wyoming County Health Department anticipates a weekly allocation of vaccine, subject to supply and delivery by New York State. **Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Wednesday, March 17, 2021, the Wyoming County Health Department reports two thousand two hundred thirty-seven (2,237) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of seven (7) cases from the last reported increase on Tuesday, March 16, 2021.
