From the Wyoming County Department of Health:

NEW: Beginning Tuesday, March 30, all New Yorkers 30 years of age and older will be eligible to receive the COVID-19 vaccine.

Registration is now open for a COVID-19 Moderna vaccination clinic for those that are eligible to be vaccinated and either live or work in Wyoming County. The clinic will be on Thursday, April 1 from 8:30am to 4:15pm at the Wyoming County Highway Department.

This clinic is for anyone currently eligible for COVID-19 vaccination per NYS Guidance [“Phased Distribution of the Vaccine”](#) including those ages 30 years and older (new as of 3/30!).

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Monday, March 29, 2021, the Wyoming County Health Department reports two thousand three hundred four (2,304) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of eighteen (18) cases from the last reported increase on Friday, March 26, 2021.
