From the Wyoming County Department of Health:

NEW: Beginning TODAY, all New Yorkers 30 years of age and older are eligible to receive the COVID-19 vaccine.

Appointments are available for a COVID-19 Moderna vaccination clinic for those that are eligible to be vaccinated and either live or work in Wyoming County. The clinic will be on Thursday, April 1 from 8:30am to 4:15pm at the Wyoming County Highway Department. This clinic is for anyone currently eligible for a COVID-19 vaccination per NYS Guidance [“Phased Distribution of the Vaccine”](#) including those ages 30 years and older (new as of 3/30!).

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Tuesday, March 30, 2021, the Wyoming County Health Department reports two thousand three hundred seven (2,307) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of three (3) cases from the last reported increase on Monday, March 29, 2021.
