**From the Wyoming County Department of Health:**

**NEW:** According to NYS, as of April 1, 2021, asymptomatic domestic travelers arriving in New York State from other U.S. states and territories **are not required** to test or quarantine. Symptomatic travelers must immediately self-isolate and contact the health department or their healthcare providers to determine if they should be tested for COVID-19. Beginning Tuesday, April 6, individuals 16 years of age and older (for Pfizer vaccine) or 18 years of age and older (for Moderna and Johnson & Johnson vaccine) can receive the COVID-19 vaccine. Please be patient while the supply of vaccine increases to meet demand.

**Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Thursday, April 1, 2021, the Wyoming County Health Department reports two thousand three hundred twenty-two (2,322) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of nine (9) cases from the last reported increase on Wednesday, March 31, 2021.
