Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan** announced as of Friday, April 2, 2021, the Wyoming County Health Department reports two thousand three hundred twenty-nine (2,329) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of seven (7) cases from the last reported increase on Thursday, April 1, 2021.
