Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan** announced as of Thursday, April 8, 2021, the Wyoming County Health Department reports two thousand three hundred eighty-eight (2,388) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of fourteen (14) cases from the last reported increase on Wednesday, April 7, 2021.
