Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan** announced as of Monday, April 12, 2021, the Wyoming County Health Department reports two thousand four hundred nineteen (2,419) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of seventeen (17) cases from the last reported increase on Friday, April 9, 2021.
