Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan** announced as of Wednesday, April 14, 2021, the Wyoming County Health Department reports two thousand four hundred thirty (2,430) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of seven (7) cases from the last reported increase on Tuesday, April 13, 2021.
