Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan** announced as of Friday, April 16, 2021, the Wyoming County Health Department reports two thousand four hundred forty-seven (2,447) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of eight (8) cases from the last reported increase on Thursday, April 15, 2021.
