Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Wednesday, April 21, 2021, the Wyoming County Health Department reports two thousand four hundred eighty-six (2,486) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of seven (7) cases from the last reported increase on Tuesday, April 20, 2021.
